

# Manor Club at Ford's Colony

Description of:

The Manor Club at Ford's Colony, A Condominium  
Phase I

ALL the certain parcel of land lying, being and situated in the Powhatan Magisterial District of James City County, Virginia; surrounded and contained within the property known as Ford's Colony (formerly Middle Plantation); and commonly known as "The Manor Club at Ford's Colony, A Condominium - Phase I" bounded and more particularly described as follows:

TOGETHER with non-exclusive easements for vehicular and pedestrian traffic across certain roadways as described in and subject to the terms and conditions set forth in that certain Supplemental Declaration of Protective Covenants dated November 9, 1990 made by Realtec Incorporated and Ford's Colony Homeowners Association and recorded in the Clerk's Office of the Circuit Court of James City County, Virginia in Deed Book 494 at page 822, as amended by Amendment dated May 11, 1993 and recorded in Deed Book 618 at page 88. The roadways referred to above are shown on maps and plats recorded in the Clerk's Office of the Circuit Court of James City County, Virginia, in Plat Book 46 at

page 79 (and on other plats referenced on this map) and in Plat Book 40 at page 63 and in Plat Book 31 at pages 61-72. Realtec Incorporated, Ford's Colony Homeowners Association, their successors and assigns, and others also have the right to utilize such easements and the easement areas burdened thereby.
